- After provisional allocation of seat, candidate shall have to report to the allocated college for verification of documents and checking of eligibility. Candidate will deposit tuition fee through specified bank challan form issued by the Principal of the concerned college. The candidate will report for medical checkup/Joining, after submission of proof of fee deposition to the respective college within stipulated time period, failing which allocated seat will stand cancelled automatically without any intimation to the candidate.
- Allocation of seat is provisional subject to verification of original documents/checking of eligibility by the Principal of concerned Medical/Dental Colleges. It is sole responsibility of the Principal to authenticate the eligibility of the provisionally allocated candidate before their joining/admission.

1. All necessary information regarding the taking of PMET-2016, allocation of merit and seeking admission to MBBS and BDS courses in the various Medical and Dental colleges of Punjab affiliated to Baba Farid University of Health Sciences, Faridkot and all applicable rules and regulations, etc., are contained in this PROSPECTUS, PMET - 2016.
2. This Prospectus contains two parts:
Part-I: Pertains to the instructions/procedure how to fill online application forms for PMET- 2016, Mode of PMET-2016 and allotment of ranks. It also contains instructions/procedure how to fill online counselling form and method of allocation of seats.
Part-II: Pertains to admission to MBBS and BDS courses on the basis of PMET - 2016. This part contains the **Punjab Government Notification No. 5/5/2016-5HB-III/1185 dated 18/03/2016**. Syllabus for PMET, Specimen of Various Performa.
3. Candidates are advised to read both Part-I and Part-II of the prospectus carefully before filling and submitting the **ONLINE APPLICATION FORM and ONLINE COUNSELLING FORM** of PMET -2016.
4. **An error in filling of ONLINE APPLICATION FORM may result in rejection of such an Application Form. Corrections in the information given by the candidate in the ONLINE APPLICATION FORM shall not be permitted after conduct of PMET.**
5. The schedule of Admission/Counselling shall be notified through the Press or University website. Changes, if any, in the schedule/time table of Test/Counselling etc. will be notified through Press/website of the University i.e. www.bfuhs.ac.in. **No separate intimation letters will be sent.**
6. Candidates must retain this Prospectus with them till admission process is over. Read and comply with all instructions therein strictly.
7. Eligibility conditions for admissions are given in the Part – II of the Prospectus (As per Punjab Government Notification). The Eligibility of allocated candidate shall be determined by the Principal of concerned Medical/Dental College before Joining of the candidates.
8. **SPORTS CATEGORY CANDIDATES:** PMET – 2016 qualified candidates of Sports category must send their Gradation Certificate issued by Director Sports, Punjab and other supporting documents including Detailed Marks Card of 10+1, 10+2 examination with printout of online submitted Application Form after declaration of PMET – 2016 result to the University by **5th June, 2016**.
9. The list of the Colleges and availability of seats shown at various places in this prospectus may vary and **the final status shall be displayed at the time of counselling.**
10. It is for the information of all the candidates that compulsory courses in computer applications will be instituted by the University along with professional curriculum in due course. These courses shall be compulsory for all students registered under Medical/Dental/Nursing faculties of this University. The fee structure for these courses will be separate and will be notified later on by the University.

11. **The candidate should read the eligibility conditions carefully and just appearing in PMET does not entitle him/her for admission.** Eligibility conditions for admissions are given in the Notification. The candidates will appear in PMET at their own risk & responsibility. Allocation of seat is provisional subject to verification of original documents/checking of eligibility by the Principal of concerned Medical/Dental College. It is sole responsibility of the Principal to authenticate the eligibility of the allocated candidate before joining/admission. Those who are not eligible as per Punjab Government Notification will not be considered for admission.
12. **Correct category must be filled carefully in the Online Application Form. No claim shall be allowed if category/categories are not indicated in Online Application Form. Only those candidates who claim reservation by filling category (ies) code in Online Application Form shall be considered for reserved seat.**
13. **This is for the information of all candidates that as per Hon'ble Supreme Court of India, if any incident of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain and if his explanation is not found satisfactory, the authority would expel him from the institution.**
14. University has started Health Sciences Library Network (HSLIBNET) to provide access to e-resources to the students of all colleges affiliated with the University for which Rs. 1000/- per year will be charged from all Medical and Dental students.
15. **Post Matric Scholarship Scheme:** SC category candidates are entitled for scholarship from the Department of Welfare, Govt. of Punjab if they fulfill their terms and conditions. SC category candidates, whose family annual income from all sources is less than Rs. 2.5 lacs, are entitled for post matric scholarship as per guidelines of Govt. of India and Punjab Govt. The respective candidates will have to produce an income declaration by the self-employed parents / guardians, stating definite income from all sources by way of an affidavit on-judicial stamp paper. Employed parents/guardians are required to obtain income certificate from their employer and for any additional income from other sources, they would furnish declaration by way of an affidavit on non-judicial stamp paper. PART-I

1. INTRODUCTION

BRIEF HISTORY:

The University was established at Faridkot under an Act of Punjab State Legislature (Punjab Act No. 18 of 1998) in the name of great Sufi Saint Sheikh Farid Ganj-E-Shakar, (1173-1265 A.D.) in 1998 for purposes of affiliating, teaching and ensuring proper and systematic instruction, training and research in Modern Systems of Medicine and Indian Systems of Medicine. It is not only affiliating and examining body but also a teaching and research centre in health sciences. It is expected to play a vital role in improving the standards of medical and health education in the state and in conducting relevant research in all aspects of health sciences, basic as well as applied, which ultimately will ameliorate the health standards of the people of Punjab. It is believed that the university will be a trend setter in developing appropriate modes and models of health care to ensure quality health care to the people.

The University has been recognized by MCI vide letter no. V/11015/3/2000-ME (UG) dated 9th June, 2000. The UGC has also included the University in the list of recognized universities maintained by the University Grants Commission, under section 2(1) of the UGC Act. 1956 vide letter no. F.9-3/97 (CPP-I) dated 4 July. 2002. The Regional Director, World Health Organization, Regional Office for South-East Asia, World Health House, New Delhi has also forwarded the name of the University for inclusion in the World Directory of Medical Schools vide letter No. M12/6212 dated 6 May 2002. The University is also included in the list of Commonwealth Universities and their yearbook 2001 at page No. 692 (Vol. I).

Established with a mission to create an intellectual, academic and physical environment conducive to free flow of ideas and exchange of information between various faculties of the university, between this university and other universities of health sciences in the country and abroad, thereby opening a window to the world for the health professionals, health planners, health managers, biomedical and social scientists and educationalists in health sciences of the country. Efforts are on to establish contact with various institutions towards achieving this goal.

UNIVERSITY'S PRESENT STATUS:

All the new buildings of the University and its constituent college, GGS Medical College & Hospital were completed in the year 2011. The university was shifted to its new building situated at Sadiq Road, Faridkot in July 2011. Hon'ble Chief Minister, Punjab. Inaugurated two new University buildings (Senate Block and Academic Block) on 22-09-2011. Hon'ble Deputy Chief Minister inaugurated the Radiotherapy Unit, and other buildings of GGS Medical College & Hospital, on 23-09-2011. The GGS Medical College & Hospital, a constituent college of the University is also shifted to its new building.

The University Campus comprises of GGS Medical College along with Auditorium of 800 capacity, Senate Block, Academic Block, University College of Physiotherapy, University College of Nursing, Drug De-addiction Centre, Telemedicine, Edusat and a well equipped state-of-the-art 500 bedded hospital. Coveted projects to set up Trauma Centre, Regional Cancer Centre all in process. The University has added to its academic convoy University Library & Informatics Division, Department of Health Sciences Library & Information System, University Centre of Excellence in Research, Rose Garden and Herbal Garden.

UNIVERSITY'S NEW PROJECTS:

University is on the way to establish:

- 1) Advanced Cancer Diagnostic, Treatment & Research Centre at Bathinda.
- 2) University Regional Centre for Public Health & Paramedical Sciences at Goindwal Sahib. University has acquired 20 Acres of land for its Regional Center at Goindwal Sahib. Hon'ble Chief Minister, Punjab has already inaugurated both the projects in October 2011. The University has planned to run a number of employment-oriented diploma courses and certificate programmes in health sciences.

The University is also in process of developing the following five study centres:

- 1) Centre for Distance Learning (Medical) and Educational Technology miscellaneous.
- 2) Centre for Health Systems and Health Services Management.
- 3) Centre for Bio-information Technology.
- 4) Centre for Human Resources Development and Health Management.
- 5) Centre for Population Sciences.
- 6) University Institute of Nursing, Jalalabad, Distt. Fazilka attached with upcoming 100 bedded Hospital.

UNIVERSITY'S CONSTITUENT COLLEGES:

The Government of Punjab incorporated the three institutions as constituent colleges of the Baba Farid University of Health Sciences, Faridkot viz. School of Nursing (upgraded to University College of Nursing) vide notification no. 11/299/01-5SS3/4770 dated 14.10.2002, Guru Gobind Singh Medical College & 500 bedded Hospital. Faridkot vide notification no. 8/02/2005-1HB-111/6308 dated 31.10.2006 and State Institute of Nursing & Paramedical Sciences, Badal vide notification no. 1/46/07-1HBIV/1163 dated 28.11.2007. In addition to above, the Board of Management of University also accepted the proposal for starting of Physiotherapy College in the University campus in its meeting held on dated 03.04.2007 and fourth constituent college was established viz. University College of Physiotherapy. University has also established its own Institute of Pharmacy. Recently, Govt. of Punjab has transferred 100 bedded Civil Hospital, Badal to University for strengthening and expanding the connection between rural medical services and the education and research carried on by the Baba Farid University of Health Sciences. The GGS Medical College & Hospital, a constituent college of the University has 25 departments and 7 post graduate departments and is recognized by MCI.

COLLEGES AFFILIATED WITH UNIVERSITY:

At present the University is having 148 affiliated colleges comprising 140 affiliated and 8 constituent Colleges (with an approximately 35,000 students).

University will soon endeavor to achieve excellence in health care delivery and medical education and research in the State. Admissions to various undergraduate and post graduate courses in the affiliated institutions of this University in the State of Punjab are made on merit basis through the conduct of Entrance Tests.

The university is now primarily focusing on strengthening postgraduate medical education and research and evolving as a centre of excellence in a rural backdrop.

Selection of the candidates to any institution shall be made on merit and in transparent manner as per Punjab Government Notification/s.

College Inspections:

The University has started conducting the surprise inspections of all the colleges and due to this, the colleges are compelled to maintain their standard related to academic staff, discipline and availability of amenities etc. Moreover, the University has started highlighting the shortcomings which the colleges have failed to rectify. This information is made available to the prospective students at the time of admission, before they select the college of their choice.

University Examination System:

The University is going to introduce Onscreen Marking Solution and e-transfer system of question papers of various courses to the examination centres w.e.f session 2016 to maintain the sanctity of examinations. This process and implementation strategies will help us to deliver, efficiency, reliability in high stakes examination and their certifications.

2. The Governor of Punjab is pleased to authorize Baba Farid University of Health Sciences, Faridkot to conduct Punjab Medical Entrance Test-2016 (PMET-2016) and to conduct centralized counselling for admissions on the basis of marks obtained in PMET-2016.
3. The admission to the MBBS/BDS courses in all the categories except NRI shall be based on marks obtained in PMET-2016. Admission for NRI candidates shall be based on merit in qualifying exam. (As per decision of the Hon'ble Punjab and Haryana High Court in LPA No. 1448 of 2015)
4. Candidate must have completed the age of 17 years on or before 31st December of the admission year.
5. Candidate must have passed in the subjects of Physics, Chemistry, Biology/Biotechnology and English individually and must have obtained a minimum of 50% marks (45% for Persons with Locomotor Disability of Lower Limbs and 40% for SC/BC) taken together in Physics, Chemistry and Biology/ Biotechnology (PCB) in 10+2 examination or other equivalent examination of 10+2.
6. **Candidate should have passed qualifying examination as under:**
 - a. The higher secondary examination or the Indian School Certificate Examination which is equivalent to 10+2 Higher Secondary Examination after a period of 12 years study, the last two years of study comprising of Physics, Chemistry and Biology after the introduction of the 10+2+3 years education structure as recommended by the National Committee of Education;

OR

 - b. Any other examination which, in scope and standard is found to be equivalent to the Intermediate Science examination of an Indian University/Board, taking Physics, Chemistry and Biology/ Biotechnology including a practical test in each of these subjects and English;
7. In order to be eligible for admission to MBBS/BDS course, it shall be necessary for the candidate to obtain minimum of 50% marks (45% for Persons with Locomotor Disability of Lower Limbs and 40% for SC/BC categories) in PMET-2016.

The inter-se-merit of candidates for tie-breaking in PMET-2016 shall be determined in the following manner:

- a. Candidates obtaining higher marks in Biology (Botany & Zoology) in the PMET-2016.
- b. Candidates obtaining higher marks in Chemistry in the PMET-2016.
- c. Candidates older in age.

8. After the declaration of the PMET-2016 result, the candidates shall apply on the specific proforma for all seats except All India quota seats to Baba Farid University of Health Sciences, (BFUHS), Faridkot. Admission shall be made by the selection committee through a centralized counselling by BFUHS, Faridkot on the basis of inter-se merit of PMET-2016
9. Admission to private institutions shall be made as per the provisions of the Punjab Private Health Sciences Educational Institutions (Regulation of Admission, Fixation of Fee & Making of Reservations) Act 2006.
10. A candidate from reserved Category shall have the right to compete for admission in open merit or General category seats as per his/her merit on the day of counselling and candidate so selected shall not be counted towards admission in the reserve category.
11. The schedule of counselling, admission and start of classes shall be in conformity with the schedule laid down by Medical Council of India/Dental Council of India/ Hon'ble Supreme Court of India / State Government. Fee and other charges for submission of the application and counselling shall be notified by the University as per Government approval.
12. Out of the total seats in government institutes, 15% seats (All India Quota) in MBBS/BDS courses shall be filled by the Government of India through centralized counselling by Central Board of Secondary Examination on the basis of marks obtained in AIPMT-2016. (Rest 85% seats shall be filled by the selection committee constituted by the Government of Punjab).
13. The details of the institutions and category wise seats shall be available on the official website of Baba Farid University of Health Sciences, Faridkot i.e. www.bfuhs.ac.in.
14. The candidate should be a bonafide resident of Punjab. The resident status of Punjab state shall be taken in terms of Punjab Government, Department of Personnel and Administrative reforms (PP-II Branch) letter No. 1/3/95-3 PP II/9619, dated 6th June,1996, ID No.1/2/96-3PP-2/8976,dated 7th July,1998 and ID No.1/3/95-3PP/II/81, dated 1st January 1999 and any further instructions issued by the Department of Personnel, if any, and the same shall be adhered. Candidate must have passed 10+1 and 10+2 examination from Punjab. Candidate who passed his/her 10+1 and 10+2 examinations or other equivalent examination from a recognized School/Institution situated in Chandigarh (Union Territory), who is bonafide residents of Punjab shall also be eligible.

The following categories shall be exempted from this condition:-

- i) Children/wards/dependents (whose parents are not alive) of all those regular Punjab Government employees, members of All India Services born on Punjab cadre, Serving Judges and the employees of the Punjab and Haryana High Court, employees of Boards/Corporations/Statutory Bodies established by an act of the State of Punjab who have been holding post outside Punjab on or before 1st January of the year of passing 10+2 examination and their children/wards/dependants were compelled to do class XI and/or XII outside Punjab.
- ii) Children/wards/dependents (whose parents are not alive) of all those regular Central Government employees, employees of Boards/Corporations/Statutory Bodies of the Central Government who have remained posted inside Punjab for at least two years out of the three years preceding year of

passing 10+2 examination but were posted outside Punjab for some time during these three years due to which their children/wards/dependants were compelled to do class XI and/or XII or equivalent qualifying examination outside Punjab. However those who remained posted in Punjab continuously for these three years shall not be entitled to be exempted as they are equally placed with other Punjab Government employees posted in Punjab.

- iii) Children/wards/dependents (whose parents are not alive) of all those Punjab Government pensioners who have retired on or before 1st January of the year of passing 10+2 examination and have settled outside Punjab on or before 1st January of the year of passing 10+2 examination and their children/wards/dependants were compelled to do class XII outside Punjab.
- iv) Children/wards/dependents (whose parents are not alive) of those military/ para-military forces personnel who were born in the territory of Punjab as per their service record at the time of entry into service.
- v) Children/wards/dependents (whose parents are not alive) of those Ex-employees of military/ Para military forces who were born in the territory of Punjab as per their service record at the time of entry into the service and have retired on or after 1st January of the year preceding two years of the year of passing 10+2 examination.
- vi) Candidates belonging to minority community who are competing for the minority quota in the minority institutions.
- vii) Candidates seeking admission under NRI category.
- viii) Wards of defence personnel posted in Punjab.

Note: Provided however, that in case adequate number of candidates aren't available for BDS course, candidates who are not residents of Punjab shall also be considered as per All India Test, AIPMT- 2016 merit.

Result not declared - The candidate, whose result of qualifying examination is not declared till the last date of applying, shall have to produce the result of qualifying examination by the time of counselling. Marks obtained in Mathematics in Class XII examination shall not be considered for admission to MBBS/BDS courses.

- (ii) The eligibility of the candidates shall be determined by the Baba Farid University of Health Sciences, Faridkot, who shall issue an eligibility certificate to each such candidate.
- (iii) Seats under NRI quota shall be filled by Category-I candidates. In case seats remain vacant only then Candidates of Category-II shall be considered. In other words if sufficient number of

candidates under Category-I are eligible and available then they shall be admitted first even if students under subsequent category i.e. category- II are higher in merit.

- (iv) The fee notified for NRI category shall be applicable to NRI candidates getting admission to Government Medical/Dental colleges also.
- (v) The NRI students shall have to give a bank guarantee/surety bond for the balance of fee, if they opt to pay the fee in installments as provided.
- (vi) The centralized counselling of NRI quota seats shall be held before the counselling for other categories. In case of any seat remaining vacant under NRI quota, during / after 2nd centralized counselling of NRI quota in state colleges, shall go to General category and in the unaided-private colleges/minority colleges shall go to General Category of the management/minority quota. The NRI left over seats shall be filled by the same Counselling Committee from amongst the eligible Candidates of PMET-2016.

21. **Declaration to be submitted by the candidate**

The Candidate and his parent / guardian shall submit a sworn declaration that the candidate has not passed the qualifying examination from more than one Board / University and had not been selected in MBBS/BDS course in any other State / UT except central counselling by Central Board of Secondary Education.

22. **Candidates already admitted:-**

Any candidate, who has taken admission in the previous session in MBBS/BDS course, shall not be eligible to seek admission again in the same course on the basis of merit in PMET-2016.

However, if any candidate who is admitted during the academic session in any institute/course may opt for admission based on marks of PMET-2016 by submitting a sworn declaration at the time of counselling that he/she had surrendered the seat against which he was already admitted.

23. **GENERAL CONDITIONS**

- a) The University shall display combined merit list of all candidates including reserve category and also a separate merit list of different categories which should be displayed on the University website at least 7 days before the counselling.
- b) The admission shall be made to only those institutes which are approved from all authorities and affiliated to the University on or before the first counselling. Institute (s) which has applied for affiliation and/or for approval of competent authority (ies) but are unable to get affiliation and such approval from all authorities before this day shall not be considered for counselling.
- c) In order to ensure completion of the prescribed courses (s) and period of study as well as commencement of examination(s) in time, no admission(s) adjustment(s) shall be made after 30th September regardless of any vacancy(ies) that might exist or might arise thereafter for any reason.
- d) The seats of All India quota remaining unfilled, if surrendered by the Director General of Health Services (Medical Examination Cell, New Delhi), to the Punjab Government, shall be advertised again by the University and shall be filled through AIPMT-2016 merit.

- e) In case of candidates whose parents are not alive, the dependency certificate shall have to be taken from the Deputy Commissioner of the District where the candidate resides.
- f) The reservation for SC shall be calculated on total seats of institution after deduction of All India Quota seats.
- g) Students claiming benefits of reservation under SC/BC category shall be required to produce a certificate from the competent authority as per latest instructions. The Backward Class Certificate must be as per the latest instructions of the Government of Punjab in which the annual income of the family is specifically certified.
- h) Scheduled Caste/BC category candidates shall be eligible to apply for Post Matric Scholarship and reimbursement of fee if they fulfill the terms and conditions laid down by Department of Welfare, Punjab.
- i) As per MCI Notification No. 34(41)2008-MED/54469 dated 23 March 2009, 3% seats shall be filled-up by candidates with locomotor disability of lower limbs between 50 to 70%. Provided that in case any seat in this 3% quota remains unfilled on account of un-availability of candidates with locomotor disability of lower limbs between 50 to 70% then any such un-filled seat in this 3% quota shall be filled-up by persons with locomotor disability of lower limbs between 40 to 50%.
 Following categories of handicapped will not be eligible for admission as per the instructions of MCI:-
- i. Handicapped by hand/hands
 - ii. Handicapped by eye sight
 - iii. Deafness
 - iv. Handicapped of legs more than 70%
- Successful handicapped candidates must appear before the Medical Board at Guru Gobind Singh Medical College, Faridkot on specified date notified by the BFUHS, Faridkot before counselling.**
- j) Seats remaining vacant under any of the reserve category shall be transferred to the general category.
24. In view of the judgment dated 02.07.2014 in CWP No. 6009 of 2014 and connected cases by the Hon'ble Punjab and Haryana High Court, the eligibility criteria from session 2019-2020 onwards shall be as under:-
 "The candidate shall have passed his/her 10th Class examination and also 10+1 and 10+2 from the State of Punjab."

Physics - scope and excitement; nature of physical laws; Physics, technology and society.

Need for measurement: Units of measurement; systems of units; SI units, fundamental and derived units. Length, mass and time measurements; accuracy and precision of measuring instruments; errors in measurement, significant figures. Dimensions of physical quantities, dimensional analysis and its applications.

Unit II: Kinematics

Frame of reference. Motion in a straight line: Position-time graph, speed and velocity. Uniform and non-uniform motion, average speed and instantaneous velocity. Uniformly accelerated motion, velocity-time, position-time graphs, relations for uniformly accelerated motion (graphical treatment). Elementary concepts of differentiation and integration for describing motion, Scalar and vector quantities: Position and displacement vectors, general vectors and notation, equality of vectors, multiplication of vectors by a real number; addition and subtraction of vectors. Relative velocity. Unit vector: Resolution of a vector in a plane - rectangular components. Scalar and vector product of vectors. Motion in a plane. Cases of uniform velocity and uniform acceleration-projectile motion. Uniform circular motion.

Unit III: Laws of Motion

Intuitive concept of force. Inertia. Newton's first law of motion; momentum and Newton's second law of motion; impulse: Newton's third law of motion. Law of conservation of linear momentum and its applications. Equilibrium of concurrent forces. Static and kinetic friction, laws of friction. rolling friction, lubrication. Dynamics of uniform circular motion: Centripetal force, examples of circular motion (vehicle on level circular road. vehicle on banked road).

Unit -IV Work, Energy and Power

Work done by a constant force and a variable force; kinetic energy, work-energy theorem, power. Notion of potential energy, potential energy of a spring, conservative forces: conservation of mechanical energy (kinetic and potential energies); non-Conservative forces, motion in a vertical circle; elastic and inelastic collisions in one and two dimensions.

Unit-V Motion of System of Particles and Rigid Body

Centre of mass of a two-particle system, momentum conservation and centre of mass motion. Centre of mass of a rigid body; centre of mass of uniform rod. Moment of a force, torque, angular momentum, conservation of angular momentum with some examples. Equilibrium of rigid bodies, rigid body rotation and equations of rotational motion, comparison of linear and rotational motions; moment of inertia, radius of gyration. Values of moments of inertia for simple geometrical objects (no derivation). Statement of parallel and perpendicular axes theorems and their applications.

Unit-VI Gravitation

Keplar's laws of planetary motion. The universal law of gravitation. Acceleration due to gravity and its variation with altitude and depth. Gravitational potential energy; gravitational potential. Escape velocity, Orbital velocity of a satellite. Geo-stationary satellites.

Unit-VII Properties of Bulk Matter

Elastic behaviour, Stress-strain relationship, Hooke's law, Young's modulus, bulk modulus, shear, modulus of rigidity, poisson's-ratio; elastic energy Pressure due to a fluid column, Pascal's law and its applications (hydraulic lift and hydraulic brakes). Effect of gravity on fluid pressure. Viscosity, Stokes' law, terminal velocity, Reynold's number, streamline and turbulent flow. Critical velocity. Bernoulli's theorem and its applications. Surface energy and surface tension, angle of contact, excess of pressure, application of surface tension ideas to drops, bubbles and capillary rise. Heat, temperature, thermal expansion; thermal expansion of solids, liquids and gases, anomalous expansion, specific heat Capacity: C_p , C_v -calorimetry; change of state-latent heat. Heat transfer-conduction, convection radiation and

thermal Conductivity, Qualitative idea of Blackbody radiation, Newton's law of cooling and Stefan's law, Wein's displacement law, Green House effect.

Unit-VIII Thermodynamics

Thermal equilibrium and definition of temperature (zeroth law of thermodynamics). Heat, work and internal energy. First law of thermodynamics. Isothermal and adiabatic processes. Second law of thermodynamics: reversible and irreversible processes. Heat engines and refrigerators.

Unit-IX Behaviour of Perfect Gas and Kinetic Theory

Equation of state of a perfect gas, work done on compressing a gas. Kinetic theory of gases. Assumptions, concept of pressure. Kinetic energy and temperature; rms speed of gas molecules; degrees of freedom, law of equipartition of energy (statement only) and application to specific heat capacities of gases: concept of mean free path, Avogadro's number.

Unit-X Oscillations and Waves

Periodic motion - period, frequency, displacement as a function of time. Periodic functions. Simple harmonic motion (S.H.M) and its equation; phase; oscillations of a spring-restoring force and force constant; energy in S.H.M.-kinetic and potential energies: simple pendulum-derivation of expression for its time period: free, forced and damped oscillations (qualitative ideas only), resonance. Wave motion. Longitudinal and transverse waves, speed of wave motion. Displacement-relation for a progressive wave. Principle of superposition of waves, reflection of waves, standing waves in strings and organ pipes, fundamental mode and harmonics, Beats, Doppler effect.

Unit-XI: Electrostatics

Electric Charges; and their Conservation, Coulomb's law-force between two point charges, forces between multiple charges; superposition principle and continuous charge distribution. Electric field, electric field due to a point charge, electric-field lines; electric dipole, electric field due to a dipole; torque on a dipole in uniform electric field. Electric flux, statement of Gauss's theorem and its applications to find field due to infinitely long straight wire, uniformly charged infinite plane sheet and uniformly charged thin spherical shell (Field inside and outside). Electric potential, potential difference, electric potential due to a point charge, a dipole and system of charges; equipotential surfaces, electrical potential energy of a system of two point charges and of electric dipole in an electrostatic field. Conductors and insulators, free charges and bound charges inside a conductor. Dielectrics and electric polarisation, capacitors and capacitance, combination of capacitors in series and in parallel, capacitance of a parallel plate capacitor with and without dielectric medium between the plates, energy stored in a capacitor, Van de Graaf generator.

Unit-XII: Current Electricity

Electric current, flow of electric charges in a metallic conductor, drift velocity, mobility and their relation with electric current: Ohm's law, electrical resistance. V-I characteristics (linear and non linear), electrical energy and power, electrical resistivity and conductivity. Carbon resistors, colour code for carbon resistors; series and parallel combinations of resistors; temperature dependence of resistance. Internal resistance of a cell, potential difference and emf of cell, combination of cells in series and in parallel. Kirchhoff's laws and simple applications. Wheatstone bridge, meter bridge. Potentiometer-principle and its applications to measure potential difference and for comparing emf of two cells, measurement of internal resistance of a cell.

Unit-XIII: Magnetic Effects of Current and Magnetism

Concept of magnetic field. Oersted's experiment; Biot-savart law and its application to current carrying circular loop. Ampere's law and its applications to infinitely long straight wire, straight and toroidal solenoids. Force on a moving charge in uniform magnetic and electric fields. Cyclotron. Force on a current-carrying conductor in a uniform magnetic field Force between two parallel current-carrying conductors, definition of ampere. Torque experienced by a current loop in uniform magnetic field; moving coil galvanometers- its current sensitivity and conversion to ammeter and voltmeter. Current loop as a magnetic dipole and its magnetic dipole moment. Magnetic dipole moment of a revolving electron. Magnetic field intensity due to a magnetic dipole (Bar magnet) along its axis and perpendicular to its axis. Torque on a magnetic dipole (bar magnet) in a uniform magnetic field; bar magnet as an equivalent solenoid, magnetic field lines; Earth's magnetic field and magnetic elements, Para-, dia-and ferro-magnetic substances with examples, Electromagnets and factors affecting their strengths. Permanent magnets.

Unit-XIV: Electromagnetic Induction and Alternating Currents

Electromagnetic induction, Faraday's laws, induced emf and current, Lenz's Law, Eddy currents: Self and mutual inductance. Alternating current, peak and rms value of alternating current/voltage; reactance and impedances; LC oscillations, (qualitative treatment only), LCR series circuit resonance; power in AC circuit, wattless current. AC generator and transformer.

Unit-XV: Electromagnetic Waves

Need for displacement current, Electromagnetic waves and their characteristics (qualitative ideas only). Transverse nature of electromagnetic waves. Electromagnetic spectrum (Radio waves, Radio-microwaves, infra-red, visible, ultraviolet, X-rays, gamma rays) including elementary facts about their uses.

Unit-XVI: Optics

Reflection of light, spherical mirrors, mirror formula. Refraction of light, total internal reflection and its applications, optical fibers, refraction at spherical surfaces, lenses, thin lens formula, lens-maker's formula. Magnification, power of a lens, combination of thin lenses in contact, combination of lens and mirror. Refraction and dispersion of light through a prism. Scattering of light-blue colour of the sky and reddish appearance of the sun at sunrise and sunset. Optical instruments: Human eye, image formation and accommodation, correction of eye defects (myopia, hypermetropia) using lenses. Microscopes and astronomical telescopes (reflecting and refracting) and their magnifying powers. Waves optics: wave front and Huygens' Principle, reflection and refraction of plane wave at a plane surface using wave fronts. Proof of laws of reflection and refraction using Huygens' Principle. Interference. Young's double hole experiment and expression for fringe width, coherent sources and sustained interference of light. Diffraction due to a single slit, width of central maximum. Resolving power of microscopes and astronomical telescopes. Polarisation, plane polarised light -Brewster's law, uses of plane polarised light and Polaroids.

Unit-XVII: Dual nature of Matter and Radiation

Photoelectric effect, Hertz and Lenard's observations; Einstein's photoelectric equation, particle nature of light. Matter waves-wave nature of particles, de Broglie relation. Davission-Germer experiment (experimental details should be omitted; only conclusion should be explained).

Unit-VIII: Atoms & Nuclei

Alpha-particle scattering experiment; Rutherford's model of atom; Bohr model, energy levels, hydrogen spectrum. Composition and size of nucleus, atomic masses, isotopes, isobars; isotones. Radioactivity- alpha, beta and gamma particles/rays and their properties; radioactive decay law. Mass-energy relation, mass-defect; binding energy per nucleon and its variation with mass number; nuclear fission and fusion,

Unit-XIX: Electronic Devices

Energy bands in solids (qualitative idea only) conductor, insulators and Semiconductors; semiconductor Diode-I-V characteristics in forward and reverse bias, diode as a rectifier, I-V characteristics of LED, photodiode, solar cell and Zener diode, Zener diode as a voltage regulator. Junction transistor, transistor action; characteristics of a transistor: transistor as an amplifier (common emitter configuration) and oscillator, Logic gates (OR, AND, NOT, NAND and NOR). Transistor as a switch.

Unit-XX: Communication Systems

Elements of a communication system (block diagram only); bandwidth of signals (speech, TV and digital data); bandwidth of transmission medium- Propagation of electromagnetic waves in the atmosphere, Sky and space wave propagation. Need for modulation. Production and detection of an amplitude modulated wave.

CHEMISTRY

Unit-I Some Basic Concepts of Chemistry

General introduction: Importance and scope of chemistry. Historical approach to particulate nature of matter, laws of chemical combination. Dalton's atomic theory: concept of elements, atoms and molecules. Atomic and molecular masses. Mole concept and molar mass: percentage composition, empirical and molecular formula; chemical reactions, stoichiometry and calculations based on stoichiometry.

Unit-II Structure of Atom

Discovery of electron, proton and neutron; atomic number, isotopes and isobars. Thomson's model and its limitations, Rutherford's model and its limitations. Bohr's model and its limitations, concept of shells and subshells, dual nature of matter and light, De Broglie's relationship, Heisenberg uncertainty principle, concept of orbitals, quantum numbers, shapes of s, p, and d orbitals, rules for filling electrons in orbitals - Aufbau principle, Pauli exclusion principle and Hund's rule, electronic configuration of atoms, stability of half filled and completely filled orbitals.

Unit-III Classification of Elements and Periodicity in Properties

Significance of classification, brief history of the development of periodic table, modern periodic law and the present form of periodic table, periodic trends in properties of elements -atomic radii, ionic radii, Inert gas radii. Ionization enthalpy, electron gain enthalpy, electronegativity, valence, Nomenclature of elements with atomic number greater than 100.

Unit-IV Chemical Bonding and Molecular Structure

Valence electrons, ionic bond, bond parameters, covalent bond. Lewis structure, polar character of covalent bond, covalent character of ionic bond, valence bond theory. resonance, geometry of covalent molecules, VSEPR theory, concept of hybridization involving s, p and d orbitals and shapes of some simple molecules, Molecular orbital theory of homonuclear diatomic molecules(qualitative idea only), hydrogen bond.

Unit-V States of Matter: Gases and Liquids

Three states of matter. Intermolecular interactions, types of bonding, melting and boiling points. Role of gas laws in elucidating the concept of the molecule, Boyle's law. Charles' law, Gay Lussac's law, Avogadro's law. Ideal behaviour, empirical derivation of gas equation, Avogadro's number. Ideal gas equation. Deviation from ideal behaviour, liquifaction of gases, critical temperature, kinetic energy and molecular speeds (elementary idea) Liquid State - Vapour pressure, viscosity and surface tension (qualitative idea only, no mathematical derivations).

Unit-VI: Solid State

Classification of solids based on different binding forces: molecular, ionic, covalent and metallic solids, amorphous and crystalline solids (elementary idea), unit cell in two dimensional and three dimensional lattices, calculation of density of unit cell, packing in solids packing efficiency, voids, number of atoms per unit cell in a cubic unit cell, point defects, electrical and magnetic properties. Band theory of metals, conductors, semiconductors and insulators and n and p type semiconductors.

Unit VII: Solutions

Types of solutions, expression of concentration of solutions of solids in liquids, solubility of gases in liquids, solid solutions, colligative properties – relative lowering of vapour pressure, Raoult's Law, elevation of boiling point, depression of freezing point, osmotic pressure, determination of molecular masses using colligative properties, abnormal molecular mass. Vant Hoff factor.

Unit-VIII Thermodynamics

Concepts of System, types of systems, surroundings. Work, heat, energy, extensive and intensive properties, state functions. First law of thermodynamics - internal energy and enthalpy heat capacity and specific heat measurement of ΔU and ΔH , Hess's law of constant heat summation, enthalpy of: bond dissociation, combustion, formation, atomization, sublimation. Phase transition, ionization, solution and dilution. Introduction of entropy as a state function, Gibbs energy change for spontaneous and non-spontaneous processes, criteria for equilibrium and spontaneity. Second law of thermodynamics, third law of thermodynamics (Brief introduction).

Unit-IX Equilibrium

Equilibrium in physical and chemical processes, dynamic nature of equilibrium, law of mass action, equilibrium constant, factors affecting equilibrium - Le Chatelier's principle; ionic equilibrium ionization of acids and bases, strong and weak electrolytes, degree of ionization, ionization of polybasic acids, acid strength, concept of pH, Henderson Equation. Hydrolysis of salts (elementary idea). Buffer solutions, solubility product, common ion effect (with illustrative examples).

Unit X: Chemical Kinetics

Rate of a reaction (average and instantaneous), factors affecting rates of reaction; concentration, temperature, catalyst; order and molecularity of a reaction: rate law and specific rate constant, integrated rate equations and half life (only for zero and first order reactions); concept of collision theory (elementary idea, no mathematical treatment). Activation Energy, Arrhenius equation.

Unit-XI Redox Reactions

Concept of oxidation and reduction, redox reactions, oxidation number, balancing redox reactions in terms of loss and gain of electrons and change in oxidation number, applications of redox reaction.

Unit XII: Electrochemistry

Redox reactions; conductance in electrolytic solutions, specific and molar conductivity, variations of conductivity with concentration, Kohlrausch's Law, electrolysis and laws of electrolysis (elementary idea) dry cell-electrolytic cells and Galvanic cells; lead accumulator, EMF of a cell, standard electrode potential, Nernst equation and its application to chemical cells, fuel cells; corrosion. Relation between Gibbs Energy change and EMF of cell.

Unit XIII: Surface Chemistry

Absorption physisorption and chemisorption; factors affecting adsorption of gases on solids; catalysis; homogenous and heterogeneous, activity and selectivity; enzyme catalysis; colloidal state: distinction between true solutions, colloids and suspensions; lyophilic, lyophobic, multimolecular and macromolecular colloids; properties of colloids; Tyndall effect, Brownian movement, electrophoresis, coagulation; emulsion-types of emulsions.

Unit XIV: General Principles and Processes of Isolation of Elements

Principles and methods of extraction – concentration, oxidation, reduction electrolytic method and refining; occurrence and principles of extraction of aluminum, copper, zinc and Iron.

Unit-XV Hydrogen

Position of hydrogen in periodic table, occurrence, isotopes, preparation, properties and uses of hydrogen; hydrides - ionic, covalent and interstitial; physical and chemical properties of water, heavy water; hydrogen peroxide preparation reactions, structure and use; hydrogen as a fuel.

Unit-XVI S Block Elements (Alkali and Alkaline earth metals)**Group 1 and Group 2 elements**

General introduction, electronic configuration, occurrence, anomalous properties of the first element of each group, diagonal relationship, trends in the variation of properties (such as ionization enthalpy, atomic and ionic radii), trends in chemical reactivity with oxygen, water, hydrogen and halogens; uses.

Preparation and properties of some important compounds:

Sodium carbonate, sodium chloride sodium hydroxide and sodium hydrogen carbonate, biological importance of sodium and potassium. CaO, CaCO₃ and industrial use of lime and limestone, biological importance of Mg and Ca.

Unit-XVII Some p-Block Elements, General introduction to p-Block Elements

Group 13 elements: General introduction, electronic configurations, occurrence. Variation of properties, oxidation states, trends in chemical reactivity, anomalous properties of first element of the group; Boron- physical and

chemical properties, some important compounds: borax, boric acid, boron hydrides. Aluminium: reactions with acids and alkalis and uses.

Group 14 elements: General introduction, electronic configurations, occurrence, variation of properties, oxidation states, trends in chemical reactivity, anomalous behaviour of first element, Carbon - catenation, allotropic forms, physical and chemical properties; uses of some important compounds: oxides. Important compounds of silicon and a few uses: silicon tetrachloride, silicones, silicates and Zeolites, their uses.

Unit XVIII: p-Block Element

Group 15 elements: General introduction, electronic configuration, occurrence, oxidation states, trends in physical and chemical properties; nitrogen - preparation, properties and uses; compounds of nitrogen- preparation and properties of ammonia and nitric acids, oxides of nitrogen (structure only); Phosphorous-allotropic forms; compounds of phosphorous preparation and properties of phosphine, halides ($\text{PCl}_3, \text{PCl}_5$) and oxoacids (elementary idea only).

Group 16 elements: General introduction, electronic configuration, oxidation states, occurrence, trends in physical and chemical properties; dioxygen; preparation, properties and uses; classification of oxides; Ozone. Sulphur - allotropic forms; compounds of sulphur preparation, properties and uses of sulphur dioxide, sulphuric acid, industrial process of manufacture, properties and uses, oxoacids of sulphur (structures only).

Group 17 elements: (General introduction, electronic configuration, oxidation states, occurrence, trends in physical and chemical properties; compounds of halogens; preparation, properties and uses of chlorine and hydrochloric acid, interhalogen compounds, oxoacids of halogens (structures only).

Group 18 elements: General introduction, electronic configuration. Occurrence, trends in physical and chemical properties, uses.

Unit-XIX: d and f Block Elements

General introduction, electronic configuration, occurrence and characteristics of transition metals, general trends in properties of the first row transition metals-metallic character, ionization, enthalpy, oxidation states, ionic radii, colour, catalytic properties, magnetic properties, interstitial compounds, alloy formation. Preparation and properties of $\text{K}_2\text{Cr}_2\text{O}_7$, and KMnO_4 .

Lanthanoids - electronic configuration, oxidation states, chemical reactivity and lanthanoid contraction and consequences.

Actinoids - Electronic configuration, oxidation states and comparison with lanthanoids.

Unit-XX: Coordination Compounds

Coordination compounds - introduction, ligands, coordination number, colour, magnetic properties and shapes, IUPAC nomenclature of mononuclear coordination compounds, bonding; Werner's theory, VBT, CFT, Isomerism (structure and stereo) importance of coordination compounds (in qualitative analysis, extraction of metals and biological systems).

Unit-XXI Organic Chemistry Some Basic Principles and Techniques

General introduction, methods of purification, qualitative and quantitative analysis, classification and IUPAC nomenclature of organic compounds. Electronic displacements in a covalent bond:- inductive effect, electromeric effect, resonance and hyper conjugation. Homolytic and heterolytic fission of a covalent bond: free radicals, carbocations, carboanions, electrophiles and nucleophiles, types of organic reactions

Unit-XXII Hydrocarbons

Classification of hydrocarbons

Aliphatic Hydrocarbon

Alkanes Nomenclature isomerism, conformations (ethane only), physical properties, chemical reactions including, free radical mechanism of halogenation, combustion and pyrolysis.

Alkenes - Nomenclature, structure of double bond (ethene) geometrical isomerism, physical properties, methods of preparation; chemical reactions: addition of hydrogen, halogen, water, hydrogen halides (Markovnikov's addition and peroxide effect), ozonolysis, oxidation, mechanism of electrophilic addition.

Alkynes – Nomenclature, structure of triple bond (ethyne), physical properties. Methods of preparation, chemical reactions: acidic character of alkynes, addition reaction of - hydrogen, halogens, hydrogen halides and water.

Aromatic hydrocarbons: Introduction, IUPAC nomenclature: Benzene; resonance aromaticity: chemical properties: mechanism of electrophilic substitution. – nitration sulphonation, halogenation, Friedel Craft's alkylation and acylation: directive influence of functional group in mono-substituted benzene; carcinogenicity and toxicity.

Unit-XXIII: Haloalkanes and Haloarenes.

Haloalkanes: Nomenclature, nature of C-X bond, physical and chemical properties, mechanism of substitution reactions, optical rotation.

Haloarenes: Nature of C-X bond, substitution reactions (directive influence of halogen for monosubstituted compounds only)

Uses and environmental effects of - dichloromethane, trichloromethane, tetrachloromethane, iodoform, freons, DDT.

Unit –XXIV: Alcohols, Phenols and Ethers

Alcohols: Nomenclature, methods of preparation, physical and chemical properties (of primary alcohols only); identification of primary, secondary and tertiary alcohols; mechanism of dehydration, uses, with special reference to - methanol and ethanol.

Phenols: Nomenclature, methods of preparation, physical and chemical properties, acidic nature of phenol, electrophilic substitution reactions, uses of phenols.

Ethers: Nomenclature, methods of preparation, physical and chemical properties, uses.

Unit-XXV: Aldehydes, Ketones and Carboxylic Acids

Aldehydes and Ketones: Nomenclature, nature of carbonyl group, methods of preparation, physical and chemical properties, and mechanism of nucleophilic addition, reactivity of alpha hydrogen in aldehydes; uses.

Carboxylic Acids: Nomenclature, acidic nature, methods of preparation, physical and chemical properties; uses.

Unit-XXVI: Organic compounds containing Nitrogen

Amines: Nomenclature, classification, structure, methods of preparation, physical and chemical properties, uses, identification of primary, secondary and tertiary amines.

Cyanides and Isocyanides - will be mentioned at relevant places in context.

Diazonium Salts: Preparation, chemical reactions and importance in synthetic organic chemistry.

Unit-XXVII: Biomolecules

Carbohydrates - Classification (aldoses and ketoses), monosaccharides (glucose and fructose), oligosaccharides (sucrose, lactose, maltose), polysaccharides (starch, cellulose, glycogen); importance

Proteins - Elementary idea of amino acids, peptide bond, polypeptides proteins, primary structure, secondary structure, tertiary structure and quaternary structure (qualitative idea only), denaturation of proteins; enzymes.

Vitamins: Classification and functions.

Harmones: Elementary idea (excluding structure)

Nucleic Acids: DNA & RNA .

Unit-XXVIII: Polymers

Classification - natural and synthetic, methods of polymerization (addition and condensation), co-polymerization. Some important polymers; natural and synthetic like polythene, nylon, polyesters, bakelite, rubber. Biodegradable and Non- Biodegradable Polymers.

Unit-XXIX: Chemistry in everyday life:

1. Chemicals in medicines analgesic, tranquilizers, antiseptics, disinfectants, antimicrobials, antifertility drugs, antibiotics, antacids, antihistamines.

2. Chemicals in food- preservatives, artificial sweetening agents. Elementary idea of antioxidants.

3. Cleansing agents - soaps and detergents, cleansing action.

Unit-XXX Environmental Chemistry

Environmental pollution - air, water and soil pollution, chemical reactions in atmosphere, smog, major atmospheric pollutants; acid rain, ozone and its reactions, effects of depletion of ozone layer; greenhouse effect and global warming - pollution due to industrial wastes: green chemistry as an alternative tool for reducing pollution, strategy for control of environmental pollution.

What is living?; Biodiversity; Need for classification; Three domain of life; Taxonomy & Systematic; Concept of species and taxonomical hierarchy; Binomial nomenclature; Tools for study of Taxonomy-Museums, Zoos, Herbaria, Botanical gardens.

Five Kingdom classification; Salient features and classification of Monera; Protista and Fungi into major groups; Lichens; Viruses and Viroids.

Salient features and classification of plants into major groups-Algae, Bryophytes, Pteridophytes, Gymnosperm and Angiosperm. Angiosperms-classification up to class, characteristics features and examples.

Salient features and classification of Animals-non chordate up to phyla level and chordate up to classes level (three to five salient features and at least two examples)

Unit II Structural Organization in Animals and Plants

Morphology and modifications; Tissues; Anatomy and functions of different parts of flowering plants: Root, stem, leaf, inflorescence-cymose and racemose, flower, fruit and seed (To be dealt along with the relevant practical of the practical syllabus).

Animal tissues; Morphology, anatomy and functions of different systems (digestive, circulatory, respiratory, nervous and reproductive) of an insect (cockroach). (Brief account only)

Unit III Cell Structure and Function

Cell theory and cell as the basic unit of life; Structure of prokaryotic and eukaryotic cell; Plant cell and animal cell; Cell envelope, cell membrane, cell wall; Cell organelles-structure and function; Endomembrane system-endoplasmic reticulum, Golgi bodies, lysosomes, vacuoles; mitochondria, ribosomes, plastids, microbodies; Cytoskeleton, cilia, flagella, centrioles (ultra structure and function); Nucleus-nuclear membrane, chromatin, nucleolus.

Chemical constituents of living cells: Biomolecules- structure and function of proteins, carbohydrates, lipid, nucleic acid; Enzymes-types, properties, enzyme action.

Cell division: Cell cycle, mitosis, meiosis and their significance.

Unit IV Plant Physiology

Respiration: Exchange of gases; Cellular respiration- glycolysis, fermentation (anaerobic), TCA cycle and electron transport system (aerobic); Energy relations- Number of ATP molecules generated; Amphibolic pathways; Respiratory quotient.

Plant growth and development: Seed germination; Phases of plant growth and plant growth rate; - Conditions of growth; Differentiation, dedifferentiation and redifferentiation, Sequence of developmental process in a plant cell; Growth regulators-auxin, gibberellin, cytokinin, ethylene, ABA; Seed dormancy; Vernalisation; Photoperiodism.

Unit V Human Physiology

Digestion and Absorption: Alimentary canal and Digestive glands; Role of digestive enzymes and gastrointestinal hormones; Peristalsis, Digestion, absorption and assimilation of proteins, carbohydrates and fats, Calorific value of proteins, carbohydrates and fats; Egestion; Nutritional and digestive disorders - PEM, indigestion, constipation, vomiting, jaundice, diarrhea.

Breathing and Respiration: Respiratory organs in animals (Recall only); Respiratory system in humans; Mechanism of Breathing and its regulation in humans - Exchange of gases, transport of gases and regulation of respiration, Respiratory volumes; Disorders related to respiration - Asthma, Emphysema, Occupational Respiratory disorders.

Body fluids and Circulation: Composition of blood, Blood groups, Coagulation of blood; Composition of Lymph and its function; Human circulatory system - Structure of human heart and blood vessels; Cardiac cycle, Cardiac output, ECG; Double circulation; Regulation of cardiac activity; Disorders of circulatory system - Hypertension, Coronary artery disease, Angina pectoris, heart failure.

Excretory products and their elimination: Modes of excretion - Ammonotelism, ureotelism; Uricotelism; Human excretory system – structure and function; Urine formation, Osmoregulation; Regulation of kidney-function - Renin-angiotensin, Atrial Natriuretic Factor, ADH and Diabetes insipidus; Role of other organs in excretion; Disorders - Uraemia, Renal failure, Renal calculi, Nephritis; Dialysis and artificial kidney.

(Common disorders eg. Dwarfism, Acromegaly, Cretinism, goiter, exophthalmic goiter, diabetes, Addison's disease).

Diseases related to all the human physiology systems.

Reproduction health: Need for reproductive health and prevention of sexually transmitted diseases (STD); Birth control – Need and Methods, Contraception and Medical Termination of Pregnancy (MTP); Amniocentesis; Infertility and assisted reproductive technologies-IVF, ZIFT, GIFT.

Unit VIII. Biology and Human Welfare

Health and Disease: Pathogens; parasites causing human diseases (Malaria, Filariasis, Ascariasis, Typhoid, Pneumonia, common cold, amoebiasis, ring worm); Basic concepts of immunology-vaccines; Cancer, HIV and AIDS; Adolescence, drug and alcohol abuse.

Improvement in food production: plant breeding, tissues culture, single cell protein, Biofortification, Apiculture and animal husbandary.

Microbes in human welfare: In household food processing, industrial production, sewage treatment, energy generation and as biocontrol agents and biofertilizers.

Environmental issues: Air pollution and its control; Water pollution and its control; Agrochemicals and their effects; Solid waste management; Radioactive waste management; Greenhouse effect and global warming; Ozone depletion; Deforestation; Any three case studies as success stories addressing environmental issues.

I am directed to invite your attention to the Punjab Government Circular Letter No.1/3/95-3PP II/2043, dated 29/1/1996 vide which the instructions were issued regarding simplification of procedure for obtaining the certificate of Domicile for purposes of admission to educational institutions (including technical/medical institution). The matter has been reconsidered in the light of judgement delivered by the Hon'ble Supreme Court of India in the case of Dr. Pradeep Jain Vs. Union of India and others reported as AIR 1984-SC-4121 wherein it was held that instead of the word 'Domicile' the word 'Residence' be used in the instructions issued by the State Government on the subject. Accordingly, it has been decided by the Government to revise the Government instructions referred to above as under:

Subject: Issuance of certificate for the purpose of seeking admission to various educational/technical/professional institutions in the state and also for employment.

Sir,

It has been brought to the notice of Government that educational authorities and institutions prescribe various certificates regarding residence, SC/BC category and backward area etc. to be furnished by the students/candidates with the applications forms for entrance examinations or employment in the formats and by the authorities different from those prescribed by the Government departments. Cases have also been reported where the authorities concerned insist on retaining original certificates and refuse to accept the attested photo copies of the certificates. All this results in harassment and panic among the students/candidates and their parents/guardian, since they have to apply with such certificates to more than one authorities simultaneously and within a limited period. The lists of certificates required at the time of applying for CET/PMET/PMT and PAU are enclosed by way of illustration.

2. In order to overcome the difficulty mentioned above, it has been decided by the Government that following procedure has been decided by the Government that the following procedure shall be followed meticulously by all the educational and other authorities concerned:-

- i) Certificates issued in the format and by the authorities prescribed by the Government Departments shall be accepted as valid by all educational institutions and other authorities.
- ii) Where a number of authorities have been authorized to issue the certificates there shall be no insistence on issue of a certificate by any particular authority or by the highest authority indicated in the format.
- iii)(a) In case of entrance examinations, no certificate should be called for in the first instance alongwith the application form. It will be sufficient for the candidate seeking admission or other facility to indicate in the application form whether he/she belongs to any particular category entitling him/her to certain concessions or facility. Requisite certificates may be obtained only from the selected/wait listed candidates.
- iii)(b) To further simplify the procedure attested copies of the certificates only shall be retained and original certificates if required to be produced at the time of interview shall be returned immediately, thereafter.
- iv) Parents/guardian or candidates can also obtain SC certificates from the Head of the institution where the candidates has studied if the proof is available in the school records.
- v) The persons who are employed in Government of India or any other State Government are to be treated at par with the employees of the Government of Punjab in the matter of issue of Scheduled Caste certificate provided relevant Scheduled Caste certificate exists in their service record. The Scheduled Caste certificate in such will be issued by the respective Heads of Departments in the Proforma below:-

2. It is intimated that the candidates seeking admission against the following category of defence personnel in case of 85% state quota who are bonafide resident of Punjab State should produce a certificate from the Army/Navy/Air Force Headquarters or the Commanding Officer of the Unit countersigned by the Director, Defence Services Welfare Punjab in the case of Serving Defence Personnel. In the case of Ex-Servicemen certificate should be signed by the concerned District Defence Services Welfare Officer countersigned by the Director, Defence Services Welfare Punjab:-

- (a) Killed in action
- (b) Disabled in action to the extent of 50% or above & Medically Boarded out from service
- (c) Died while in service & Death attributable to military service
- (d) Disabled in service & boarded out with disability attributable to military service
- (e) Gallantry Award/other award winners both retired in service
- (f) Ex-serviceman/Serving Defence Personnel

3. The above said benefit is only for the wards of Punjab State Defence personnel only.
