An "All India Common Entrance Test" (AICET-2016) for Admission to MBBS Course in Constituent Units of Member Universities.

In accordance with the **Apex Court decision in TMA Pai and PA Inamdar Vs Union of India cases and <u>the Medical Council of India Graduate Medical Education Regulation, 1997</u>. Association of Private Universities Madhya Pradesh will be conducting an Entrance Test which is fair, transparent and non-exploitative. Thus under the supervision of Madhya Pradesh Private Universities Regulatory Commission AICET-2016** is being conducted for admission in MBBS Course in constituent units of Private Universities of Madhya Pradesh.

1. PREAMBLE:

In compliance with the Medical Council of India The Graduate Medical Education Regulation, 1997, Association of Private Universities Madhya Pradesh for Professional Institutions constituted in terms of Law laid by the **Hon'ble Supreme Court in case of Islamic Academy of Education is conducting an All India Common Entrance Test (AICET-2016)** for admission to MBBS Course in People's College of Medical Sciences & Research Centre, Bhopal, L.N. Medical College & Research Centre, Bhopal and RKDF Medical College Hospital & Research, constituent units of private universities.

4. AVAILABILITY OF APPLICATION FORMS AND BROCHURES

• Application Forms is available at Association Website. The downloaded Application Form filled in all respect may be submitted along with Demand Draft of Rs. 3000/- (Form Fee+ Examination Fee) in favour of, Association of Private Universities Madhya Pradesh payable at Bhopal.

Before filling the application form the candidate must familiarize himself/herself with the information given in this brochure and shall satisfy his/her eligibility to appear in the examination. The candidate is required to go through the information brochure carefully and acquaint himself/herself with all requirements with regard to the filling-in of the Application Form.

- The Application Forms complete in all respect should be submitted to the Controller of Examination, 45, Nishat Colony, Gate No.1, Bhopal-462011 by Registered / Speed Post/Courier/in person. Last date for submission of Application Forms is 10th May 2016 (upto 06:00pm) and 12th May 2016 (upto 06:00pm) with late fees of Rs. 500/-.
- Candidate shall write Name and Contact Number on the back of Demand Draft.
- Incomplete Application Forms will be rejected.

5. INSTRUCTIONS FOR FILLING UP APPLICATION FORM.

Note: Form should be filled by the candidate by himself/herself own handwriting. It is suggested that candidate make a photocopy of the Form and use that for practice. Please fill the form with great care, request for corrections will not be entertained at any stage, incomplete filled Application Forms will be rejected without any notice. Candidates should read all the instructions carefully and fill the Form with utmost clarity. They should use **Blue/Black Ball Point Pen only**. <u>Fill the Form in English using CAPITAL LETTERS only</u>.

- 5.1 **Name of the Candidate:** Write first name, then middle name (abbreviate if necessary) and then surname in the boxes provided on top of the circles. Leave a box blank between first, second and surname.
- 5.2 **Date of Birth of Candidate:** In the first column two boxes are provided; write the date in the boxes. Thereafter Two boxes are provided, write the month (if born in Jan write 01) and in the third column two boxes are given. Write the year (if born in year 1991 write 9 and 1).
- 5.3 **Sex:** Tick the appropriate Column Male or Female in the box provided.
- 5.4 **Courses: Tick the choice of course. Candidate appearing for <u>AICET-2016</u> are eligible for any course available in the counselling if qualify for that course whether opted or not.**
- 5.5 **Choice of Centers:** Tick up the choice of the two centers in order of preference and write Centre Code No. **FIRST & SECOND** choice.

- 5.6 **Name of Parent/Guardian:** Write first name, then middle name (abbreviate if necessary) then surname in the boxes provided. Leave a box blank between names.
- 5.7 Mailing address should be clearly written entirely inside the boxes. Write your address and finally PIN code. Write address in capital letters only.
- 5.8 If you have contact telephone/mobile numbers please fill in the boxes.
- 5.9 A recent colour high contrast 3.5 cm. x 4.5 cm. size photograph is required. Only photograph of the front profile with full face, head, shoulder and with both ears visible and taken without wearing any cap or hat or sunglasses will only be accepted. Polaroid photo is NOT acceptable. Photograph must be taken on or after 1st January, 2016 with a playcard indicating the name of the candidate (as in the application form) and the date of taking photograph.

In case name and date are written on the photograph after taking it, the application will be rejected.

The name and date on the photograph must be clear and legible.

Photograph should be pasted in such a manner that full profile or head, face and shoulder entirely inside the box and no where else. **Do not uses pin/staple to fix the photograph. Do not attest or sign the photograph.**

- 5.10 Signature should be made by the Candidate himself/herself entirely inside the box.
- 5.11 **Thumb Impression:** Apply your left thumb impression using **BLUE/RED STAMP PAD** ink in the space provided in application form. Allow the ink to get complete dry.

NOTE:

- (a) All the particulars in the Application Form must be written carefully and legibly by the candidate in his/her own hand writing.
- (b) The candidates are advised to keep the photocopy of application form (of both sides). If any candidate demand photocopy of application form it will be provided by **Association office** on payment of **Rs.500/-**
- (c) Any attempt on the part of a candidate to influence the authorities, directly or indirectly will be treated as disqualification of candidature for admission.

7. ELIGIBILITY

(A). MINIMUM EDUCATIONAL QUALIFICATION

For admission to MBBS Course, those candidates who have passed the qualifying examination of 10+2 from Board of Secondary Education M.P. or CBSE having passed in Physics, Chemistry and Biology subjects individually and have secured at least minimum 50% marks in Physics, Chemistry and Biology combined together and must have passed in English also.

OR

Those who have passed any equivalent or higher examination with the aforesaid subjects from any other recognized Board, University with the percentage of marks as mentioned above.

OR

Any other qualification recognized by Govt. of India/Medical Council of India as recognized qualification for admission to MBBS Course.

Note: No Domicile is required any Indian Citizen can apply.

9. MARKING THE ANSWER SHEET

The **AICET-2016** will consist of one common question paper of 3 hours duration in the subjects of Physics, Chemistry, Biology (Botany and Zoology) consisting of 200 multiple choice questions where subject wise distribution will be as under:

Botany	50 Questions
Zoology	50 Questions

10. DURATION AND MEDIUM OF EXAMINATION

Duration of examination will be of 3 hours. The medium of the test shall be English only.

11. AWARD OF MARKS IN LIEU OF CANCELLED/DEFECTIVE QUESTIONS:

After the completion of test, the Admission Committee will get each question on the question paper examined by "**subject-experts**" alongwith the answers suggested by the paper-setter and moderator. If any question is found to be defective by these experts, then it will be cancelled.

Question can be cancelled due to following reasons;

- i) Wrong structuring of the question.
- ii) More then one option being correct.
- iii) None of the option being correct.
- iv) Any printing error leading to a situation where more than one answer may be correct or none of the answers may be correct.

In lieu of such cancelled questions, every candidate will be awarded extra marks in proportion to the marks obtained by him/her, irrespective of the fact whether the candidate had attempted such cancelled questions or not.

The answers prepared by the "**subject experts**" shall be final and binding.

12. ADMIT CARD

- Admit Card of candidates shall be uploaded on our website one week before the Examination.
- No candidate will be allowed to appear for **AICET-2016** unless he/she holds valid admit card issued by the Controller of Examination, **AICET-2016**.
- The candidate is required to preserve the Admit Card for all future reference and correspondence.

13. AGE LIMIT

He/She shall complete the age of 17 years on or before 31st December of the year of admission to the MBBS Course and should not be more than 25 Years of Age.

14. EXPLANATION

For reckoning the age as aforesaid the date of birth as mentioned in the certificate of Higher Secondary School Certificate Examination or the mark sheet of the said examination or an equivalent examination of a recognized Board/ University shall be deemed to authentic.

15. NRI SEATS

(A) NRI Seats will be filled up as per Hon'ble Supreme Court Judgment in I.A. No. 57 and 59 in Civil Appeal No. 4060/2009 dated 3rd April, 2012.

(B) Minimum Educational Qualification [Medical Colleges]

The candidates seeking admission against NRI quota, should have passed the qualifying examination of 10+2 from Board of Secondary Education M.P. or CBSE having passed in Physics, Chemistry and Biology subjects individually and have secured at least minimum 50% marks in Physics, Chemistry and Biology combined together and must have passed in English also.

OR

Those who have passed any equivalent or higher examination with the aforesaid subjects from any other recognized Board, University with the percentage of marks as mentioned above.

OR

Any equivalent examination 10+2, M.P. Board of Secondary Education/CBSE/Qualifying examination outside India recognized by Medical Council of India for admission to MBBS course.

16. HOW TO APPLY

The NRI candidates shall apply directly to the Head of the concerned Institution in the application form prescribed by the Institution. **Eligible Candidates may contact the Head of the Institution regarding their admission against NRI Seats. NRI candidates are not required to appear in AICET-2016.**

The screening of the applications shall be done at the institution level. The admissions shall be done on the basis of merit list prepared from the applications received. If the seats are not filled under NRI quota then such seats shall be filled as drop out / vacant seats as per para 15 (A) above.

18. MODE OF SELECTION

On the basis of the marks obtained by candidates in the **AICET-2016** merit list will be prepared depending upon number of sanctioned seats. Remaining candidates up to a fixed number will be kept in the waiting list.

Merit criteria in case of candidates with equal marks

Merit order of candidates having secured equal total marks will be decided on the basis of marks obtained in individual subjects arranged in order of their importance as follows :

1st – Zoology	2nd – Botany
3rd – Chemistry	4th – Physics

There after the person elder in age will be preferred.

19. OPEN COUNSELLING FOR ALLOTMENT OF SEATS

- The allotment of seats shall be made to the candidates through open counselling on the basis of personal appearances. The counselling Committee will consist of:-
 - (i) All Members of Admission Committee or any one as per the decision of Madhya Pradesh Private Universities Regulatory Commission (MPPURC).
 - (ii) Nominee of MPPURC

(iii) All the Deans / Director of Medical Colleges and nominated members of APUMP.

(iv) Controller of Examinations.

- Candidates who have been allotted a seat in first counselling on merit basis, because of any reason could not join the allotted institution are also eligible to participate in second open counselling.
- The programme for counselling shall be advertised in the leading Newspapers of the State. Counselling programme shall also be available on website of the Association. **Separate call letters will not be sent.**
- Candidates shall have to travel for the counselling at their own cost.
- Candidates shall not be allowed to enter the area specified for counselling without showing the **AICET-2016** Examination RANK CARD.

- The candidate without original documents as mentioned in **Para 20 (A)** shall not be eligible for admission.
- The candidate shall wait for their turn in the order of merit. Candidates shall be called in small group of 10-20 for scrutiny i.e. verification of required original documents and if found eligible, shall further be permitted for the counselling where they shall exercise their option for allotment of any one of the available seats which shall be final and the same shall be allotted to them on the spot and the allotment letter shall be issued.
- If a Candidate due to any unavoidable circumstances does not remain present on the date and time fixed for him/her for scrutiny of the documents and counselling then such candidate, if he/she comes afterwards, shall be considered only at the stage, where the counselling is in progress irrespective of his merit. He shall be considered only if the counselling is going on, and allotment done before to other candidates on the basis of their merit shall remain unchanged.

Such candidates those who are absent or those who could not participate in the counselling due to incomplete documents shall be called in the next counseling, if seats still remain vacant.

- <u>All original documents will be verified by the concerned college at the time of admission.</u>
- Canvassing directly or indirectly for the allotment of seat would disqualify the candidate for admission. Influencing the staff by unfair means will lead to cancellation of allotted seat and such candidate will also face disqualification for appearance in the subsequent **AICET-2016**.
- Candidates selected for admission shall be subject to disciplinary rules of University/Institution/ Government and Management.
- A Candidate selected for any MBBS Course as per merit will not be allowed for change of college on mutual basis.
- The selection made by the Admission Committee as per procedure is final and will be binding on the candidate.
- Admission to the candidate will be given only after the candidate will deposit his/her allrelevant original certificates, documents alongwith the balance course fee through bank draft in favour of allotted college. Original certificates will be returned only after completion of internship.

20. Documents to be produced at time of counselling

- 1. Demand Draft of **Rs. 5,00,000/- (MBBS)** in favour of Association of Private Universities Madhya Pradesh payable at Bhopal as (Tuition fee).
- 2. Rank Card of AICET 2016.
- 3. Photocopy of filled Application Form.
- 4. Proof of Identification.
- 5. Counselling fee of Rs 1000/- in cash.
- 6. GAP Certificate if any (affidavit).

Note: Because of any reasons candidates who are unable to submit Demand Draft at the time of counselling, will have to submit an undertaking that they will submit the required Demand Draft in Association Office /Institution within 3 days after date of counselling.

- 14. Bond/Bank guarantee if required by concerned college.

21. DISQUALIFICATION FOR ADMISSION

- Any candidate himself or his/her authorized proxy if found obstructing the admission process or creating nuisance, the candidate shall be liable for disqualification from the admission process. The decision taken by the College Authority shall be final and binding.
- Not-with-standing anything stated in the Rules here-in-above, a candidate who was allotted a seat in previous year(s) and who vacate/abandon it after availing the said seat, has completed such a period of course which would result into lapse of the said seat, will not be eligible for admission unless he produces a No Objection Certificate from the college whose seat has been lapsed due to the candidate concerned.

22. FEE FOR COURSES

Fee Structure:

In accordance with the directions of Hon'ble Supreme Court of India the fees of Private Medical Colleges shall be charged as decided by the **Madhya Pradesh Private Universities Regulatory Commission**.

Note :-

****** The fee amount shall be charged by the respective colleges for the Academic Session 2016-17 as approved by University and Regulatory body. However, the fee if revised by the **Madhya Pradesh Private Universities Regulatory Commission** constituted by the Government of Madhya Pradesh, shall be binding and accordingly payable/adjustable by the candidate(s)/ college(s).

- The Committee may fix the different fees for different institution as per the guide lines of Hon'ble Supreme Court.
- **Payment of Fee:** The candidate shall be admitted on payment of one year fee at the time of admission at respective college. Out of which amount of Rs. 5.00 lakh for MBBS Course will be deposited during counselling. If the Institution/college feels that any particular student(s) may leave in midstream then the college may require the candidate either to pay fee for full course and or submit Bond/Bank guarantee of the fee for whole course in evidence to the law laid by the Hon'ble Apex Court in case of Islamic Academy of Education.

23. RANK CARD

- The candidate will receive the Rank Card by post/Available on Website after declaration of result.
- The Rank Card will contain marks obtained by the candidate and his /her merit ranking.
- **Duplicate Rank Card:** In case of loss of Original **AICET 2016** Rank Card, a duplicate Rank Card can be obtained on making an application on plain paper to the Controller, APUMP, alongwith a Demand Draft of **Rs. 1000/-** in favour of **Association of Private Universities Madhya Pradesh** payable at Bhopal or in cash.

24. ADMISSION

Consequent upon a candidate allotment for a course and college he / she is required to report on the notified date and time to the Dean / Principal of the college concerned.

25. CONDUCT AND DISCIPLINE

The student while studying in the MBBS course, if found indulging in anti national activities, unlawful activities or ragging in any form, contrary to the provisions of Act and Law and Law enforced by Government, will be liable to be expelled from the college by the Dean/Principal of the College.

- Failure of the candidate in taking full and correct statements in the application form and/ or suppression of any information is liable for disqualification of the candidate, even at later date. Such a candidate will be debarred from the entire selection process and pursuing the course of studies.
- It is the responsibility of every candidate to submit proper documents. Any attempt to submit
 documents which are not genuine, will lead to cancellation of the admission of the candidate,
 forfeiture of the fees, deposits and expulsion of the candidate from the college by the
 Admission Committee or his authorized official. The name of such candidate/s shall be
 deleted from the Merit List.
- Pursuant to the orders in W.P. (Civil) No. 615 of 1999, Hon'ble Supreme Court of India has directed the Department of Human Resources and Development, Govt. of India, to take all necessary steps to curb the menace of ragging and take severe action against the students involved in such activities. Students to take serious note of it.
- As per the provisions in "Madhya Pradesh Prohibition Ragging Act of 1999", students indulging in ragging can be punished under the Act resulting in suspension, expulsion from the college and imprisonment.
- Student failing to clear MBBS course in the stipulated time fixed by MCI and continuing thereafter shall be asked to pay proportionate fee for the remaining period of the course.
- Any issue not dealt herein above will be dealt with, when arising fully and finally by the Admission Committee.

26. JURISDICTION

In case of any legal dispute, the jurisdiction shall be limited to High Court of Madhya Pradesh only.

27. IMPORTANT INSTRUCTIONS

- 1. The candidates are advised before filling up the form, to ensure that they fulfill all the eligibility and qualifying conditions with respect to age, qualification etc. for admission to the course applied for.
- 2. The candidates <u>are not required to attach/enclose any documents with the application</u> <u>form</u>. They shall be required to produce the same at the time of counselling/Admission.
- 3. Please ensure that the Application Form is neither folded nor torn or mutilated.
- Application Form available at Association website. In case the application form has been downloaded from website should be submitted along with a Demand Draft of Rs. 3000/- (Form Fee+ Examination Fee) drawn in favour of Association of Private Universities Madhya Pradesh, payable at Bhopal.
- 5. Photograph for Application Form must be White Background, Full face both the ears and shoulders should be visible in the photograph, photograph should be in MATT finish.
- 6. The Association shall not be responsible for the application forms lost in transit; received after due date and no correspondence in this respect shall be entertained.
- 7. Canvassing directly or indirectly for the allotment of seat would disqualify the candidates for admission. Influencing the staff by unfair means will lead to cancellation" of allotted seat and such candidate will also face disqualification for appearance in the subsequent **AICET-2016** Examination.
- 8. Incomplete Application Form will be rejected.
- 9. Left Thumb impression using **<u>Blue/RED STAMP PAD INK</u>** entirely inside the box provided in Application Form.

28. <u>INSTRUCTIONS TO BE FOLLOWED IN THE EXAMINATION HALL FOR ONLINE</u> EXAMINATION

Test Pattern

- (i) Pattern of the Admission Test: The Admission Test shall consist of one paper containing 200 objective type questions (four options with one correct answer) from Physics, Chemistry, Botany and Zoology to be answered on the computer by clicking on the right option.
- (ii) The duration of the paper will be 180 minutes (03 hours).
- (iii) Language of Questions, listed options and all instructions will be in English for this **computer based online test.**
- (iv) There will be no negative marking.
- (v) Once an answer to a specific question is given & the candidate has moved to the next question, the answer cannot be changed later.
- (vi) Candidate will be provided one sheet of Paper & Pencil for Rough work which will be returned at time of exit from Exam hall.

General Instructions :

- (i) The Examination Centre will open 180 minutes (03 Hours) before the commencement of the test. Candidates are expected to assemble at the security check point after the opening of the Examination Centre.
- (ii) The candidates will have to show the issued Admit Card with photograph to the security officer for admission in the Examination Centre. Candidates who do not possess a valid Admit Card shall not be admitted to the Examination Hall under any circumstances by the Exam Centre Superintendent.
- (iii) The candidates with valid admit card will undergo a biometric attendance before the test. This will be done using a biometric device before the test.
- (iv) The candidates with valid Admit card will undergo Face capturing attendance using a Digital face capturing mechanism before the test.
- (v) At any time before or during of examination, the invigilator can check the Admit Card of the candidates to satisfy himself/herself about the identity.
- (vi) The candidates will be provided with seat numbers before the test. Candidates must find and occupy their allotted seats when asked. Any candidates found during the test in a seat or room other than the one allotted to them shall have their candidature cancelled.
- (vi) The candidates reaching the Exam Center after the completion of the initial security check shall not be permitted to appear in the examination. The initial security checks will close 120 minutes before the test.
- (vii) The candidates are strictly not allowed to carry any items listed below inside the Examination Hall. The test center will not have any provision to store, protect or handover any of these items carried by the candidates under any circumstances:
 - a. Textual material, printed or written, envelope or any other material except the Admit Card.
 - b. Calculator, Slide Rule, Log Table, Geometry Box, Electronic Digital Watch with calculator, pen, pencil, any device that can write **including mobile phone, pager**, **Bluetooth device, storage device in any form or any other electronic gadget.**
 - c. Mobile Phone, Laptop, Digital Tablet & the like.
 - d. Any form of snacks or beverages. Proper drinking facilities will be available inside the examination centre.
 - e. Female candidates are advised to not to use big size hairband or hair pins or bangles or bracelets on the exam date.
- (viii) The candidates will not be allowed to leave their seats or the Examination Room/Test Center until the Test concludes as per schedule. In case of any emergency, candidates may take special permission of the Exam Centre Superintendent on duty who shall report the same to the Examination Board in writing.
- (ix) The candidates should know how to use a Mouse for submitting their responses to the questions (a mouse is a pointing device that will detect the answer clicked by the candidate. Physically, a mouse consists of an object held in one's hand, with one or more buttons). The candidates with left hand click must inform the Exam Centre Superintendent during the biometric attendance, no requests will be entertained by the Exam Superintendent post biometric and face capturing attendance mechanism)
- (x) The candidates must submit the test within the allocated time; the test will be auto submitted in case the test is not finished within the allocated time.
- (xi) The candidates will have no objection to be recorded by a Close Circuit Television during the examination.

- (xii) The candidates will have no objection to their Mouse clicks on the screen to be recorded during the online examination.
- (xiii) The candidates will have no objection to being frisked by security and being asked to produce their respective valid admit card before entering the waiting area on the day of exam.
- (xiv) For candidates who are unable to appear on the scheduled date of test for any reason, retest or any such request shall not be extended by the Admission Committee under any circumstances.
- (xv) There will be no parking facility within the venue of the exam centre for security purposes.

UNFAIR PRACTICE & EXAMINATION RULES:

- (1) Unfair practice means an activity that allows a candidate to gain an unfair advantage over other candidates. It includes, but is not limited to:
 - a) Being in possession of papers, books, notes, electronic devices or any other material or information relevant to the examination concerned listed in General Instruction Sheet.
 - b) Someone to take an examination on behalf of the candidate (impersonation);
 - c) Breaching examination rules;
 - d) Assisting another candidate to engage in malpractice; giving or receiving assistance directly or indirectly of any kind or attempting to do so;
 - e) Contacting or communicating or trying to do so with any person, other than the Examination Staff, during the examination time in the examination centre;
 - f) Threatening any of the officials connected with the conduct of the examination or threatening any of the candidates;
 - g) Using or attempting to use any other undesirable method or means in connection with the examination.
 - h) Manipulation & fabrication of online documents viz. admit card.
 - i) Forceful entry in Examination Hall with mala fide intentions.
 - j) Affixing of fabricated photograph on the admit card.

PUNISHMENT FOR USING UNFAIR PRACTICE

If a candidate is found to have indulged in any of the above practices before, during or after the course of examination, the candidate shall be deemed to have used unfair practices at examination and marked as UNFAIR PRACTICE. Such candidates would be prohibited from taking this examination permanently in future and shall also be liable for criminal action and /or any other action as deem fit by the exam board.

How to Answer the Question and Submit Test?

- i. The candidates will be seated in front of their respective allocated seats fifteen minutes before the test and each candidate will be provided with a unique access code before the commencement of the test.
- ii. An "Online Instruction page" will be displayed to the candidates on their monitors after submission of the unique code (A monitor is a visual display for computers.)
- iii. The candidates are advised to read the instructions before the commencement of the test.
- iv. The candidates will be asked to start the test at a given time.
- v. There will be four options to each question and the candidates will be able to click any one option before moving to the next question.

- vi. The candidates can change their options as many times as they want before moving to the next question, however once the candidate has moved to the next question, they cannot change the already answered question.
- vii. Candidates can choose to skip a question and move to the next question and come back later to respond the un-attempted questions.
- viii. Candidates can only choose to Submit test only when they have reached to the last question of the test.
- ix. Only on reaching the last question, the "End Test" button will appear on the monitor/screen.
- x. On Clicking "End Test" button, the candidates will be able to submit the test.
- xi. There will be a "One Minute Left" alert on the Candidates' monitor to apprise them to submit the test within the next 60 seconds.
- xii. There will be a timer on the candidate's monitor to apprise the candidate of time left for the completion of the exam.
- xiii. The candidates must ensure that they complete the test within the allocated time frame of 180 minutes otherwise the test will be auto-submitted (It will be submitted automatically by the computer) irrespective of the number of questions being answered by the candidate.




