Details of Qualifications, etc. for Admission in to Post Graduate Courses

Applications are invited from eligible candidates for admission in to the P.G. Course detailed hereunder For admission into M.Sc. level courses, candidates belong to Andhra Pradesh, who fulfill the residential requirements of A.P. Educational Institutions Order 1974 (Presidential Order) possessing Bachelor Degrees in the fields concerned accredited by Indian Council of Agricultural Research (ICAR) only are eligible. Candidates from other states should seek admission into M.Sc. and Ph.D. courses through the All India Examination conducted by the New Delhi.

Ph.D. COURSES

Major Fields:

Faculty of Agriculture : Agronomy, Agricultural Economics, Entomology, Agricultural Extension, Genetics & Plant Breeding, Plant Pathology, Crop Physiology, Soil Science, Microbiology, Molecular Biology & Biotechnology.

Faculty of Home Science (for women only): Foods & Nutrition, Human Development & Family Studies, Family Resource Management, Textile & Apparel Designing and Home Science Extension and Communication Management.

Faculty of Agricultural Engineering & Technology: Soil & Water Engineering, Processing & Food Engineering and Farm Machinery & Power.

Qualifications: Master's Degree in the faculty and major field concerned with a minimum of 50% marks in traditional system or **OGPA of 7.50/10.00 OR 3.25/4.00. SC/ST candidates with a pass in traditional system or OGPA of 7.00/10.00 or 3.00/4.00 are eligible.** Basic Degree i.e. B.Sc.(Ag.) / B.Sc.(Home Science) / B.Tech.(Ag. Engg.) of 4 years duration is essential. **The candidates should have submitted the M.Sc. level thesis on or before the last date prescribed for the receipt of applications and must complete the thesis final viva voce examination successfully as on the date of registration in case of selected candidates.**

M.Sc. COURSES

The candidates must have passed the relevant Bachelor Degree Examination specified against each course from the ANGR Agricultural University or an institution accredited by the ICAR/ approved by the ANGRAU.

NRI / Industry Quota : In M.B.A. (Agribusiness Management) course 10% (2 Seats) are reserved for NRIs / Industry Sponsored Candidates @ 5% of the seats shall be provided to NRIs / and 5% to Industry sponsored candidates. If candidates of one category are not available they shall be allotted to the other category.

NRIs should have studied relevant bachelor degree programme prescribed against the course abroad.

For Industry Quota, the candidates should possess the qualifications prescribed above and also two years relevant experience in Agri. Business Sector. They should be sponsored by the Industry / Organization. The candidates under NRI / Industry Quota need not appear for entrance test. They shall be selected based on merit. They should indicate NRI / Industry Quota on the top of the first page of the application

Minimum marks / OGPA required at qualifying examination for admission into M.Sc. level courses: In traditional system 50% marks or an OGPA of **5.50 / 10.00 or 2.50 / 4.00**. (for SC/ST categories 40% marks in traditional system or OGPA of **5.00 / 10.00 or 2.00/4.00**). The candidates completing their graduation requirements during the year 2015-16 should submit course completion certificate issued by the Associate Dean of the college concerned.

Age: The upper age limit is 40 years as on 01-07-2016

Sale of Applications: Applications and prospectus are available in the University website:www.angrau.ac.in. *separate application should be submitted for each course alongwith the copies of certificates and the Registration Fee*. Filled in application should accompany registration fee in the form of DD for Rs.1200/-for General and Rs.800/- for SC, ST & PH categories (M.Sc. / Ph.D. courses) for each course.

The Demand Draft should be from **SBH / SBI / ANDHRA BANK** and drawn in favor of **Comptroller, Acharya N.G. Ranga Agricultural University, payable at Hyderabad. (Postal orders / Money orders will not be accepted)**

Note: If **Hall tickets** are not received in time, the candidates appearing for the PG entrance examination may obtain the duplicate hall tickets a day before the examination from the office of the Associate Dean's, Agricultural College, Bapatla and S.V. Agricultural College, Tirupati between 10.30 AM to 4.00 P.M. The candidates appearing for Ph.D entrance examination, may obtain the duplicate Hall tickets a day prior to the examination from the office of the Professor & Special Officer, Advance PG Center, Lam, Guntur between 10.30 A.M. to 4.00 P.M.

Last Date: Applications for all courses duly filled in including those sent through Employers should reach **“The Registrar, Acharya N.G.Ranga Agricultural University, Vijaya Durga Towers: M.G. Inner Ring Road: Guntur – 522 509: AP on or before 21-06-2016 by 4.00 PM**. Postal delays will not be condoned. **M.Sc. (Ag.) In-service** candidates may send **advance copies** of applications along with certificates so as to reach on or before the above date to save delay in forwarding applications by the employers. Applications may be accepted with a late fee of Rs.100/- per day upto three days only after the prescribed date. Such candidates will be allowed for entrance test / interview only on production of receipt or DD towards the payment of late fee.
