Applications are invited in prescribed proforma for admission to Ph.D. (Doctor of Philosophy) Degree. The last date for submission of the application is **08th August 2015** for 10 (ten) vacancies only. Final selection for these 10 vacancies will be on the merit as evident from the Ph.D. course work result.

The shortlisted candidates for Ph.D. Degree shall have to take an entrance examination on 21st August 2015 (Friday) at 11.00 a.m. in the premises of NUJS followed by a personal interview on 22nd August 2015 (Saturday) from 10.00 a.m. onwards.

The eligibility criteria for admission to Ph.D Degree is as follows:-

1) Ph.D -

Any candidate who satisfies the following conditions is eligible to seek registration for Ph.D. in the University upon application for provisional registration.

- 1.1 The candidate shall have LL.M degree or any Masters degree having the potentiality of interdisciplinary study with law from any university recognized by UGC or equivalent LL.M or Masters degree of foreign university with a minimum of 55% marks or equivalent CGPA. However, this condition is relaxed to 50% in case of candidates belonging to SC and ST.
- 1.2 Candidates who have qualified for UGC/SLET/SET/JRF fellowships are exempted from Entrance Test.
- 1.3 Candidates with M.Phil degree from any recognized University are exempted from Entrance Test.
- 2) M.Phil Same as for the Ph.D. except point no.1.3

3) Entrance Test

Admission to Ph.D shall be through an Entrance test followed by an interview.

- 3.1 The Entrance Test shall consist of one paper of **80 marks** with 3 hours duration. The syllabus of the paper shall cover:
 - (i) Law & Social Transformation
 - (ii) Research Methodology
 - (iii) Judicial Process
 - (iv) Indian Constitutional Law

The interview shall be for 20 marks.

3.2 Foreign candidates who have LL.M. degree from a foreign university or Indian university with a minimum of 55% marks or equivalent Cumulative Grade Point Average (CGPA) shall be exempted from Entrance Test. But they shall submit a research proposal to the satisfaction of the Doctoral Committee.

3) Fees -

- **Ph.D** Registration fees of Rs. 15,000 (Non-refundable) (at the time of registration) plus annual fees of Rs. 20,000 per annum (Non-refundable).
- M.Phil Registration fees of Rs. 15,000 (Non-refundable) (at the time of registration) plus annual fees of Rs. 20,000 per annum (Non-refundable).
- The applications need to be accompanied by a Demand Draft of Rs. 2000/- (non refundable) in favour of the Registrar,
