NOTIFICATION PROVISIONAL RESULT / MARKS OF PGP-PGO-PGASLP-MSC(P&O)-CET 2015

The Common Entrance Test for PGP/PGO/PGASLP/MSc (P&O)-CET 2015 was conducted on 09th August, 2015 by Competent Authority appointed by Government of Maharashtra. The provisional result of the same is being declared on 19th August, 2015. After the declaration of provision keys of aforesaid Four Examinations, this office has received many objections related to questions and key of PGP-CET and PGO-CET 2015 No Objections were received for PGASLP & MSc (P&O) Examination. The Competent Authority had appointed subject experts to verify the objections.

The subject experts of Physiotherapy & Occupational Therapy have opined that Four (04) questions in PGP and One (1) question in PGO Question Paper are non-evaluative. The Competent Authority on the basis of the opinion of the respective subject expert has taken a decision to make these questions "non-evaluative / invalid". The Competent Authority has decided to allot one mark each for these non-evaluative MCQs to all candidates who appeared in this examination, to the respective subject. The details of serial No. Non Evaluative / Invalid questions are shown **Table no. A-1 and A-2.**

It is further clarified that the aforesaid questions have been made non-evaluative and hence if the candidate opts for verification, the answer to these questions will appear as * in the printout of the key response.

The subject expert also opined that there is change in Answer Key in Three (03) questions from PGP & Two(02) questions in PGO-CET. It differs from the Answer Key published on the website. This Three (03) questions of PGP and Two(02) questions of PGO-CET are correct and hence these are evaluative. The evaluation has been done as per corrected key.
