**I. MASTER OF SCIENCE COURSES**

Opening date of filling the Application form through link(from) : 05<sup>th</sup> February, 2024  
Last date of filling the Application form through link : 08<sup>th</sup> April, 2024  
Date of Online Remote Proctored Admission test : 19<sup>th</sup> May, 2024 (Sunday)  
The dates and mode of examination (online/Offline) may be changed at the discretion of the university authorities.

a) **M.Sc. Forestry (43 Seats): Eligibility:** B.Sc. with at least one of the subjects namely Botany, Chemistry, Geology, Mathematics, Physics, Zoology or B.Sc. degree in Agriculture or Forestry.

b) **M.Sc. Wood Science & Technology (43 Seats): Eligibility:** B.Sc. with Physics, Chemistry and Mathematics (PCM) or B.Sc. degree in Forestry.

c) **M.Sc. Environment Management (43 Seats): Eligibility:** B.Sc. degree in any branch of basic or applied Sciences or B.Sc. Degree in Forestry or Agriculture or BE/B. Tech in Environment Science.

d) **M.Sc. Cellulose & Paper Technology (26 Seats): Eligibility:** B.Sc. with Chemistry as one of the subjects or BE/B.Tech. (Chemical or Mechanical Engineering). The 2<sup>nd</sup> year of this course is likely to be conducted at Central Pulp & Paper Research Institute (CPPRI), Saharanpur.

**II. PERCENTAGE OF MARKS (in the qualifying examination):** For (a) (b) (c) & (d) Candidates having 50% or above marks in general & OBC category and 45% marks for Scheduled Castes/Scheduled Tribes may apply.

**III. RESERVATION:** Out of the above, following seats are reserved for: (a)

**SC & ST:** 15% and 7.5% respectively (b) **Reservation to OBC:** will be provided as per the policy of GOI (c) **Physically Handicapped:** 3% reservation to the Persons with Disabilities under the Persons with Disabilities (Equal opportunities, Protection of Rights and Full Participation) Act, 1995 Chapter No. 39, and for the candidates with locomotors disabilities [one leg, one arms (without mobility restriction)] and persons with partial deafness, in **M.Sc. Forestry & M.Sc. Environment Management Courses**. The candidates will have to produce disability certificate issued by competent authority at the time of counseling for admission. (d) **ICFRE Employee:** 5 seats (supernumerary).
